FULTON COUNTY BOARD OF COMMISSIONERS Tuesday, July 5, 2022

Meeting Called to Order at 9:00 a.m. with Pledge to the Flag. Present: Bryan Lewis, Rick Ranstead, David Sommers, and Auditor Christina Sriver. Not present: attorney Holli Shorter-Pifer.

HEALTH – Denise Ostafin requests permission to rehire an employee (Pamela Moyer) for the part-time nurse position. Commissioners approve.

SHERIFF – Nothing to report

HIGHWAY – John Flint presented permit request 22-22 for consideration. Commissioner Ranstead motioned with the understanding that if a road cut is required the department must be notified; Commissioner Sommers seconded; carries 3-0. The new tandem axis chasis has been delivered to WA Jones for upfitting. The tracings for Bridger #32 and #50 were motioned for approval by Commissioner Sommers, seconded by Commissioner Ranstead; carries 3-0.

COMMUNICATIONS/EMA – Gail Karas discussed an event manager feature WTH GIS offers; discussion ensued. Gail discussed EMS issues and would like to meet with them. Rebecca Hartzler (Akron Clerk-Treasurer) would like to be included in discussions of a contract. The 911 tower has been bolted down; it is anticipated that the tower will take 5-6 weeks and this point but would like to move it along if possible.

CORONER – Jeri Good stated that she assisted 33 families so far this year. There were 109 deaths in the county at the end of June 31%. Jeri is still working with INDOT to get a sidewalk installed near Sweetgum road.

HEALTH DEPARTMENT – Denise Ostafin discussed equipment needs for the department and gave a report on COVID vaccinations.
