FULTON COUNTY COUNCIL Tuesday, September 27th, 2022

Meeting Called to Order at 4:30 p.m. with Pledge to the Flag. Present: Phyl Olinger, Ron Dittman, Randy Sutton, Ryan Zimpleman, Steve Fishburn, Lorie Hurst, Jim Showley and Auditor Christina Sriver.

RTC – Joe McCarter thanked Council for the ARPA award of funds. The Commissioners approved an ordinance yesterday to establish an infrastructure development zone. A timeline was presented to represent the progress planned for running broadband. The project is planned to be complete twenty-four months after signing contracts.

AREA 5 AGENCY ON AGING AND COMMUNITY SERVICES – Alachia Sturgess, Staff Coordinator, stated that Area 5 has been operating under Guardian Advocates Incorporate and will be merging with them. The merger will allow them to expand more. The program is volunteer based, there are three staff. The program serves from the age of eighteen upward.

CORONER – Jeri Good stated there have been 162 deaths as of yesterday: 75 women/87 men, 50 calls (31%) have been investigated by the Coroner, up from 42 last year. There have been 2 COVID-19 deaths this year. There is a new rainbow pentenyl that is being used to introduce children to the drug and has affected 21 states.

COMMUNICATIONS – Gail Karas stated the new shelter is coming along well. There was a hold-up with the electrician to be sure installation was handled correctly. The week of October 10th the antenna will be installed, they are putting equipment in the building currently. She is working on getting more AEDs with a grant. She has contacted a consulting company to quote for the last two years and future years of EMS services.

SHERIFF – Chris Sailors presented the monthly reports for August. There was a car totaled in July, the insurance proceeds amounted to \$16,248. He would like to re-appropriate the money for an additional vehicle. He received \$9,016 for auctioning vehicles that he would also like to re-appropriate. He has found a truck to purchase, he will use Commissary funds to cover the remaining cost. Steve motioned to approve, Ryan seconded; carries 7-0. Thursday morning will be the jail inspection, he invites Council to attend. Some items from the old jail were moved into storage today. He has attended courthouse security meetings and the judges would like to move forward to purchase a baggage scanner; the cost is approximated at \$25,000-\$27,000. The Prosecutor feels he will be able to use Title IV-D money. Sheriff will be attending a mental health meeting in Indianapolis tomorrow.

HIGHWAY – John Geier updated on department activities including pugging and chip sealing. They will be preparing roads for next spring. Brush cutting was completed, they are on the final pass of mowing this week for the season. The new tandem has been delivered as well as the two new pickup trucks. Snow plows will be added the pickup trucks next week. John presented a quote for a brush cutter with trade-in in the amount of \$140,392. They would like to have a forestry head installed for mulching for an additional \$11,000. He would have to appropriate the funds to MVH. Jim motioned to move forward on his request, Randy seconded; carries 7-0.
