FULTON COUNTY BOARD OF COMMISSIONERS Monday, December 19, 2022

Meeting Called to Order at 9:00 a.m. with Pledge to the Flag. Present: Bryan Lewis, Rick Ranstead, David Sommers, County Attorney Holli Shorter-Pifer. Deputy Auditor Aubry Franklin and Auditor Christina Sriver.

VACATING AN ALLEY – Two petitions were presented by attorney Andrew Perkins on behalf of Gary and Julia Kline Trust for consideration of vacating an alley on Lakeshore Drive at Bruce Lake. Philip Kline spoke of the purpose of the alleys when they were dedicated by his relatives was to allow for the owners. Juan Sanchez stated that closing the alleys would negatively impact the property values. Brian Troutman spoke of his desire to retain pubic access to the alleyways. Discussion ensued led by the Realtor who holds a listing of a home for sale in the affected area concerning the decrease in property values. Commissioner Sommers motioned to approve the alley vacation for both the north and south alleyways, Commissioner Ranstead seconded; motion fails 3-0.

SHERIFF – Sheriff Sailors reviewed the monthly reports. Settlement for the totaled vehicle will be received in the amount of \$36,656. The vehicle title was presented to Commissioners for signature. Sheriff Sailors financial figures regarding the cost of housing an inmate versus the revenue that has been received.

COMMUNICATION/EMA – Gail Karas stated that the tower light is now going to red at night. She is looking into an open line that she is being billed for by AT & T. The CEMP plan needs to be updated; she will be updating it in pieces. The large EMA truck can make it through heavy snow if needed for emergency use. Gail is working with the Superintendent of Rochester Community Schools to plan for warming shelters.

MAINTENANCE/IT – Josh Sriver stated that the current cleaning crew will not continue to be used. He has gotten a quote from Elegant Cleaning. Commissioners encourage Josh to gather two to three bids to keep the process competitive. Commissioners request no rolling contract with 30-day notice to terminate. Commissioners request the tower at the old jail to be listed on an auction site rather than having to pay to have it removed prior to demolishing the old jail.

HIGHWAY – John Geier presented permit request 22-38. Commissioner Ranstead motioned to approve, Commissioner Sommers seconded; carries 3-0. John updated on the department activities. The Community Crossings second call for projects was approved for \$1,000,000. Commissioner Sommers motioned for John to sign the acceptance agreement with INDOT, Commissioner Ranstead seconded; carries 3-0. John will be applying for a bridge grant in January. John requests to carry over up to 2 ½ vacation days, Commissioners approve.

CORONER – Jeri Good reported that there have been over 920 bicycle helmets distributed throughout the county. She assisted 65 families so far this year and 4 courtesy calls. Jeri questioned mileage claims for her deputy coroners. Commissioners tabled discussion until they can review the contracts for the deputy coroners.
