The Fulton County Drainage Board met on Monday, May 8, 2017 in the Conference Room of the Fulton County Office Building at 9:00 A.M. RE: STEVE BROWN/#624 STAHL

Landowner Steve Brown addressed the Board concerning flooding in his pasture. The Surveyor's Office inspected the area previously, instructing the landowner to add an animal guard to the outlet pipe. Steve stated a guard is in place. Steve thanked the Board for their time.
