BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF ROCHESTER, FULTON COUNTY, INDIANA, THAT:

Section 1. That the following described territory located in Rochester Township, Fulton County, Indiana, be annexed to and made a part of the incorporated City of Rochester, Fulton County, Indiana, which real estate is described as follows:

Beginning at the intersection of the East right of way line of State Road 25 and the East and West half section line in Section 4, Township 30 North, Range 3 East in Fulton County, Indiana, (the being the Northwest corner of a tract in said Section 4 within the present corporate limits of the City of Rochester); thence West along said East and West half section line to the Northeast corner of the West half of the Southwest Quarter of said Section 4. Thence South along the East boundary line of said West half of the Southwest Quarter of Section 4 to the North right of way line of the Fort Wayne Road (east Fourth Street extended); Southwesterly along the North right of way line of said Fort Wayne Road to the North line of the former Erie Lackawanna Railroad right of way. Thence Northwesterly along said North line of the former Erie Lackawanna Railroad right of way to the West section line of said Section 4. South along said West section line of said Section 4 to the South line of said former Erie Lackawanna Railroad right of way, thence Southeasterly along the South line of said right of way through said Section 4 and into the Northeast Quarter of Section 9, Township 30 North, Range 3 East, to the East right of way line of State Road 25, (that being the present North, boundary line of the corporate limits of the City of Rochester); thence North along the East right of way line of State Road 25 to the place of beginning.

Section 2. The Common Council of the City of Rochester having determined that said territory meets the legal requirements for annexation and having made appropriate plans for the furnishing of all city services to said area in accordance with the Indiana statute; this ordinance shall be in full force and effect from and after its passage and the publication thereof as provided by law.

Section 3. The Crerk-Treasurer is hereby ordered to publish this ordinance in the Rochester Sentinel once each week for two consecutive weeks immediately upon the passage of this ordinance and the signing thereof by the Mayor of the City of Rochester.
