The Board of County Commissioners met in continued session at the hour of 9:00 A. M. on Wednesday September 4, 1968. All members were present. The Auditor and Attorney were present.

In Re: FULTON COUNTY ORDINANCE NO. SL I

ORDINANCE ESTABLISHING PARTICULAR LIMITS ON CERTAIN HIGHWAYS IN THE COUNTY OF FULTON, INDIANA

WHEREAS, The Board of Commissioners of the County of Fulton, in the State of Indiana, in accordance with Section 56 of chapter 48 of the Acts of the 1939 Indiana General assembly, as amended by Section 1, Chapter 141 of the Acts of the 1959 Indiana General Assembly as amended by Section 4, Chapter 138 of the Acts of the 1967 Indiana General Assembly, desires to establish lower speed limits upon certain highways in the County of Fulton, Indiana, than the prima facie speed limits prescribed by the State Law: and

WHEREAS, The Board of Commissioners of the County of Fulton, Indiana, in accordance with the aforesaid Acts of the Indiana General Assembly, have caused an engineering and traffic investigation to be made on County Highways in said County of Fulton, Indiana, which investigations have revealed that State prima facie speed limits are greater than is reasonable or safe under conditions found to exist upon the County Highways in said County, as hereinafter stated, and said investigation further revealed that the speed limits of the County Highways, as hereinafter noted should be as hereinafter designated; and

WHEREAS, The Board of Commissioners of the County of Fulton, Indiana, desire to establish speed limits upon County Highways as hereinafter designated and set forth as the only speed limits on any of the County Highways in the County of Fulton, Indiana, which shall be lower than the State prescribed prima facie speed limits and general desire to repeal, revoke and set aside all prior speed limits heretofore established by either this Board or any other prior Board of Commissioners of the County of Fulton, Indiana.

NOW THEREFORE, BE IT ORDAINED By The Board of Commissioners of the County of Fulton, Indiana, as follows:

Section 1. It shall be unlawful for any person to drive or cause to be driven a motor vehicle at the speed greater than the speed limits as hereinafter set forth on the County Highways hereinafter designated, which speed limits on said county highways are hereby established and declared by The Board of Commissioners of the County of Fulton, Indiana, to be the maximum reasonable or safe speeds thereon, to-wit:

A. 20 miles per hour on the following County Highways:

1. On Rural Street from State Road No. 19 north to North Maple Street;
2. On Nyona Lake Road over and on the bridge located thereon at Nyona Lake;
3. On West Side Road from Ewing Road to Wolfe Point Drive a distance of approximately .6 miles;
4. On Wolfs Point Drive from West Side Drive including through Smith Addition a distance of approximately .82 miles;
5. On First Street on north side of Lake Manitau;
6. On Pear Street on north side of Lake Manitau;
7. On Boulevard Street on north side of Lake Manitau;
8. On Ferndale Street on north side of Lake Manitau;
9. On Barrett Road on north side of Lake Manitau from State Road No. 14 to County Highway No. 400 East a distance of approximately .72 miles;
10. On Bayview Drive on east side of Lake Manitau;
11. On Waterview Drive on east side of Lake Manitau;
12. On Park Road from County Highway No. 150 North south to State Road no. 14 a distance of approximately .45 miles;
13. On Olsen Road west from County highway no. 750 East for a distance of approximately .27 miles;
14. On Olsen Road east from County highway no. 750 East for a distance of approximately .45 miles;
15. On County Highway no. 1175 west from County Highway no. 1200 West (county line) a distance of approximately .46 miles;
16. On County Highway no. 650 East south from State Road No. 14 a distance of approx. .15 miles;
17. On County Highway No. 650 East north from State Road no. 14 for a distance of approx. .15 miles;

B. 25 miles per hour on the following County Highways:

1. On Country Club Drive from County Highway No 400 East for a distance of approx 1 mile;
2. On Nyona Lake Road from the west side of the bridge on said Nyona Lake Road at Nyona Lake for a distance of approximately .28 miles;
3. On Nyona Lake Road from the east side of the bridge on said Nyona Lake Road at Nyona Lake for a distance of approximately .28 miles;
4. On County Highway No. 475 West from County Highway No. 1000 South (county Line) through Fletcher's Lake for a distance of approximately .3 miles north of said Fletcher's Lake;

C. 30 miles per hour on the following county highways:

1. On Ewing Road from Division Road or 18th Street to State Road No. 14 a distance of approximately .66 miles;
2. From Ewing Road to West Side Road;
3. On County Highway No. 400 East south from State Road No. 14 to County Highway No. 75 South a distance of approximately .7 miles;
4. On County Highway No. 50 East from County Highway 100 North to County Highway No. 75 North a distance of approximately .25 miles;
5. On County Highway No. 75 North from County Highway No. 50 East to the City Limits of Rochester, Indiana, a distance of approximately .25 miles.
6. On County Highway no. 75 North from County Highway No. 50 East to County Highway No. 25 East a distance of approximately .25 miles;
7. On County Highway no. 50 East from State Road no. 14 to County Highway no. 50 North a distance of approximately .5 miles
8. On County Highway No. 100 North from the City limits of Rochester, Indiana for 7 miles.
9. On 8th Street from the City limits of Rochester, Indiana to County Highway no. 50 East a distance of approximately .25 miles.
10. On County Highway No. 50 north from County highway No. 55 East to Park Road a distance of approximately 54 miles;
11. On County Highway No. 25 East from the intersection with County Highway No. 75 North to County Highway No. 50 North a distance of approximately .25 miles;
12. Beginning one-quarter mile north on County Highway No. 750 West and the intersection of said County Highway No. 750 West with County Highway no. 400 North, thence north therefrom on said County Highway no. 750 West through Leiters Ford to County Highway No. 500 North for a distance of approximately .75 miles;
13. From the Tippenance River on County Highway designated as Old State Road No. 17, thence south through Delong following said Road to a point .8 miles south of Delong;
14. On County Highway No. 1125 West from the intersection with County highway designated as North Side Road to county highway no. 1100 West a distance of approximately .72 miles;
15. On County highway No. 1100 West south from County Highway No. 1125 West to County Highway no. 100 North a distance of approximately .25 miles;
16. On County Highway No. 1600 East south from State Road no. 114 to County Highway No. 400 south a distance of approximately .3 miles;
17. On County Highway No. 375 South west from County Highway no. 1600 East for a distance .1m.

D. 35 miles per hour on the following county highways

1. On County Highway No. 375 South from County Highway No. 600 East to County Highway No. 650 East a distance of approximately .37 miles;
2. On Division Road or 18th street from Bancroft street to Wabash, avenue;
3. On Wabash Avenue from Brown Street to Division Road or 18th street a distance of .38 miles.
4. On Goose Pond Road from West side drive to lake for approximately .4 miles.

E. 40 miles per hour on the following County Highways;

1. On division Road or 18th Street from Wabash Avenue to Ewing Road for a distance .5 miles.
2. On West Side Road from Wolfs Point drive to Goose Pond Road a distance approx. 13 miles;
3. On Wabash Avenue from 18th Street or Division Road to County Highway Designated as West Side Drive a distance of approximately 1 mile;
4. On County highway designated as 4th Street from the City Limits of Rochester, Indiana east to State Road No. 25 a distance of approximately .69 miles;
5. On County Highway No. 750 West from County Highway No. 400 North for a distance of .25 mi.;
6. From U. S. Highway No. 31 West on Nyona Lake Road for a distance of 1.27 miles;
7. On County Highway No. 400 East from the intersection with County Highway No. 75 South to County Highway No. 150 South a distance of .85 miles.

SECTION 2. Any person who shall violate Section 1 of this Ordinance by driving or causing to be driven a motor vehicle at a speed or speeds greater than the speeds as herein prescribed upon the designated County Highways shall be prosecuted by the State of Indiana and shall suffer such penalties as by the Laws of the State of Indiana provided.

SECTION 3. All prior ordinances, resolutions and motions of this Board of Commissioners or any prior Board of Commissioners of the County of Fulton, Indiana, declaring speed limits on any of the County Highways in the Fulton County Highway Road System are hereby repealed, revoked and set aside.

SECTION 4. This Ordinance shall be in full force and effect upon its passage by the Board of Commissioners of the County of Fulton, Indiana.
