ORDINANCE FOR TAX LEVIES

An Ordinance Levying Taxes and fixing the Rate of Taxation for the purpose of raising revenue to meet the necessary expense of the County Government and its Institutions for the calendar year 1950.

Be It Ordained be the Fulton County Council of Fulton County, Indiana, That:

Section 1. For the use and benefit of the County General Fund that shall be levied and assessed, in the year 1949 collectible in the year 1950, the sum of 63.7 cents on each One Hundred Dollars (\$100.00) of the assessed valuation of Taxable Property of said Fulton County, and 50 Cents on each Taxable Poll in said Fulton County, which taxes when collected shall be paid into the County General Fund in the County Treasury.

Section 2. For the use and benefit of the County Nil Fund, there shall be levied and assessed, in the year 1949, collectible in the year 1950, the sum of Nil cents on each One Hundred Dollars (\$100.00) of the assessed valuation of Taxable Property of said Fulton County, which taxes when collected shall be paid into the County Nil Fund in the County Treasury.

Section 3. For the use and benefit of the County Hospital Fund, there shall be levied and assessed, in the year 1949, collectible in the year 1950, the sum of 6.5 cents on each One Hundred Dollars (\$100.00) of the assessed valuation of Taxable Property of said Fulton County, which taxes when collected shall be paid into the County Hospital Fund in the County Treasury.

Section 4. For the use and benefit of the Hospital Bond fund, there shall be levied and assessed, in the year 1949, collectible in the year 1950, the sum of 1.3 cents on each One Hundred Dollars (\$100.00) of the assessed valuation of Taxable Property of said Fulton County, which taxes when collected shall be paid into the Hospital Bond Fund in the County Treasury.

Section 5. For the use and benefit of the Nil Fund, there shall be levied and assessed in the year 1949, collectible in the year 1950, the sum of Nil Cents on each One Hundred Dollars (\$100.00) of the assessed valuation of Taxable Property of said Fulton County, which taxes when collected shall be paid into the Nil Fund in the County Treasury.

Section 6. For the use and benefit of the County Welfare Fund there shall be levied and assessed, in the year 1949, collectible in the year 1950, the sum of 12.8 cents on each One Hundred Dollars (\$100.00) of the assessed valuation of Taxable Property of said Fulton County, which taxes when collected shall be paid into the County Welfare Fund in the County Treasury.
