

## FULTON COUNTY ORDINANCE NO.030193

WHEREAS, the 1986 session of the Indiana Legislature has added I.C. 11-12-6 to the Indiana Code to provide for the establishment and funding of a county correction fund; and

WHEREAS, I.C. 11-12-6-6 provides that a county legislative body may annually adopt an ordinance to elect to receive deposits from the State Department of Correction and to establish a county correction fund; and

WHEREAS, the county correction fund may be used only for funding the operation of the county jail, jail programs, or other local corrections facilities; and

WHEREAS, the county legislative body has elected to receive deposits at Level 3 funding; and

WHEREAS, Level 3 is the most appropriate level of participation for Fulton County; therefore

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF FULTON COUNTY, INDIANA

SECTION 1. The Board of Commissioners hereby elects to continue to receive deposits from the Department of Correction in accordance with I.C. 11-12-6.

SECTION 2. The Board of Commissioners hereby elects to receive such deposits at Level 3 funding and deposit such funds in the existing county correction fund in accordance with I.C. 11-12-6.

SECTION 3. The county correction fund shall be used for all purposes permitted by statelaw. Any money remaining in the county correction fund at the end of the year does not revert to any other fund but remains in the county correction fund.

SECTION 4. This ordinance shall be in full force and effect upon passage.


