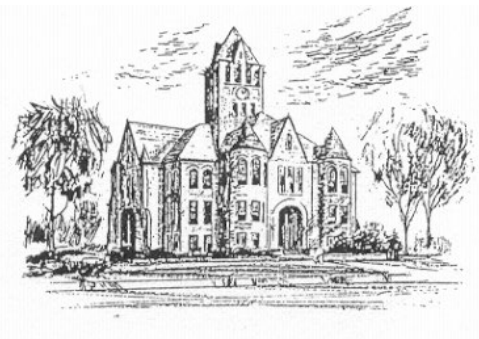
**CVS**- 1910 Main St, Rochester, contactless COVID-19 testing for patients age 3 and up.
