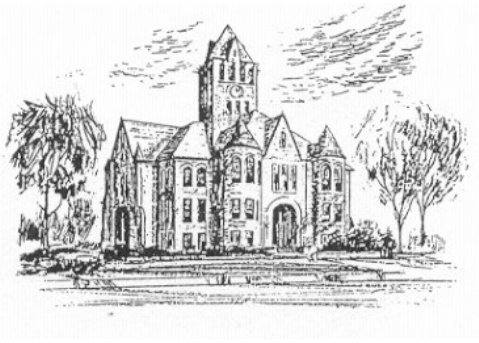

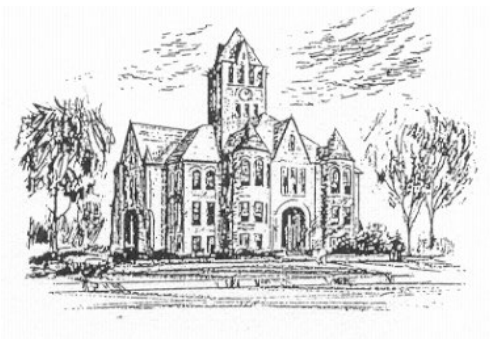

The CDC has issued booster eligibility guidance. Based on those recommendations, the Indiana Department of Health supports the administration of booster doses to individuals who attest to meeting CDC guidelines as outlined below:

- 16 and older and completed their primary vaccination series of Pfizer at least 6 months ago.
- 18 and older and completed their primary vaccination series of Moderna at least 6 months ago *or* completed their primary vaccination of Johnson & Johnson at least 2 months ago.

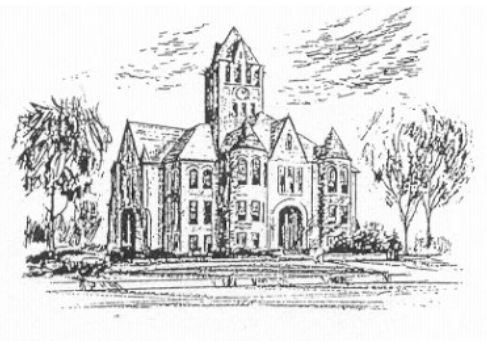
Teens 16–17 years old are only eligible to receive the Pfizer-BioNTech COVID-19 vaccine booster. Individuals 18 years and older may choose which vaccine they receive as a booster dose. Some people may have a preference for the vaccine type that they originally received and others, may prefer to get a different booster. CDC's recommendations now allow for this type of mix and match dosing for booster shots. Anyone age 5 and older may now receive a Pfizer Pediatric Covid-19 vaccine.

Pfizer Adult, Pfizer Pediatric and Moderna Primary & Booster doses all available at the Fulton County Fairgrounds.
