

"It is a crime to falsify this ballot or to violate Indiana election laws." (IC 3-11-2-7)

1. CASTING A VOTE: To vote for the candidate of your choice and to vote on a public question, completely darken the oval at the LEFT of the candidate's name or public question. Darken the oval completely, like this . If you make a mistake, return your ballot to the Election Official and obtain another. Do not attempt to change any marks made in error.

2. WRITE-IN: To cast a vote for a write-in candidate, darken the oval at the LEFT of the line for write-in voting and PRINT the name of the candidate on the line provided. A write-in vote will not be counted unless the vote is for a DECLARED write-in candidate.

3. NOTE: A ballot cast for the named candidates for President and Vice-President of the United States is considered a ballot cast for the slate of presidential electors nominated by that political party.

STRAIGHT PARTY

(1) You are not required to vote a straight party ticket. If you do not wish to vote a straight party ticket, do not make a mark in this section, and proceed to voting the ballot by office.

(2) To vote a straight ticket for all candidates of the party of your choice on this ballot, except for candidates described in (3) below, make a voting mark for the party of your choice and do not make any other marks on this ballot.

(3) To vote for any candidate for an at-large office, (county council, town council, or township board if those offices appear on this ballot), you must make another voting mark for each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office.

(4) If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must make another voting mark on the appropriate place on this ballot.
